## **ORDER**

As per the GO read as 1st paper above, Government introduced a Centralized Procurement System for the purchase of commonly used hardware items such as Desktops, Laptops, Printers, Scanners etc through an online Government portal (http://cprcs.kerala.gov.in/) developed for this purpose. M/s Keltron is entrusted as the service provider, for doing tender and deriving rates for the commonly used IT equipments, through competitive bidding process. As per GO read as 2nd paper above, detailed guidelines were issued in this regard.

In the initial tender done for Centralized procurement, the validity of rate contract for Desktops and other items were till 30th September 2018. Although, Government extended the tender validity to 3 more months till December 2018, the OEMs of Desktops were not willing to supply the Desktops for the time period due to an increase in price of the Desktops, caused due to the rise in dollar rates. Hence the supply of Desktops to the Govt. departments/LSGIs/Universities etc were kept pending.

Based on the decisions in the minutes read as 3rd paper above, KELTRON was directed to call sealed quotations for Desktops for fulfilling the demand from various departments, who have done the payment in advance. Thereby KELTRON initiated tender proceedings on 16/11/2018 by inviting sealed quotations from OEMs and finalized the rates with the consent of KSITM and Govt.

As per the letter read as 4th paper above, KELTRON after negotiating with the qualified bidders, submitted the proposal containing the rates of Desktops arrived at the limited tender as detailed below;
