G. O. (P) No. 3/2008/SWD. Dated, Thiruvananthapuram, 16th January, 2008.

S. R. O. No. 69/2008.—In exercise of the powers conferred by Section 29 of the Juvenile Justice (Care and Protection of Children) Act, 2000 (Central Act 56 of 2000), read with rule 3 of the Kerala Juvenile Justice (Care and Protection of Children) Rules, 2003, the Government of Kerala hereby constitute Child Welfare Committees for Thiruvananthapuram, Kollam, Pathanamthitta, Alappuzha, Kottayam, Ernakulam and Wayanad Districts with the members mentioned in the schedule below for exercising the powers and discharging the duties conferred on such Committees in relation to child in need of care and protection under the said Act, namely:—

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 29 of the Juvenile Justice (Care and Protection of Children) Act, 2000 (Central Act 56 of 2000) and rule 8 of the Kerala Juvenile Justice (Care and Protection of Children) Rules, 2003, empower the State Government to constitute Child Welfare Committees for each District or a group of Districts for exercising the powers and discharging the duties conferred on them by the said Act and Rules. The Government have decided to constitute Child Welfare Committees in seven Districts namely Thiruvananthapuram, Kollam, Pathanamthitta, Alappuzha, Kottayam, Ernakulam and Wayanad.

This notification is intended to achieve the above object.
