ORDER

Shri.K.Vijayan, Loom Inspector (Rtd) while working at Payyannur Khadi Centre for the period from 1992-2007 committed a liability of Rs.3,26,228/- (purchase of clothes Rs.1,51,378 , audit liability Rs.1,74,850) Kerala Khadi and Village Industries Board has issued recovery notice. Hon'ble High Court in its judgment dated 4/7/12 in WP(C) No.15519/12 filed by Sri.K.Vijayan has directed the Board to consider and finalise the appeal submitted by the petitioner before the Board within 2 months from the date of receipt of copy of the judgment. Accordingly the Board reduced an amount of Rs.80,000/- from the liability and his liability was fixed to Rs.2,46,228/- as per proceedings read as 1st above.

2. Against this order Shri.K.Vijayan filed an appeal dated 11/12/14 before the Government. He also filed WP(C)No.34341/14 and the High Court in its judgment dated 18/12/14 has directed the Secretary, Industries Department to consider and pass appropriate orders in accordance with law, after giving an opportunity of hearing within 3 months from the date of receipt of Judgment.

3. As per judgment Shri.K.Vijayan,Loom Inspector (Rtd) and Shri.S.Suresh Babu Law Officer, Kerala Khadi and Village Industries Board were heard on 21/3/2015 by the Joint Secretary to Government, Industries Department. Shri.K.Vijayan informed

that he joined in the KKVIB Payyannur Khadi centre as loom inspector on 1990 and continued in the same category till his retirement on 31/5/2007. Stock was verified on 31/3/2007, when charge was handed over to Shri.P.V.Sasidharan. Spare parts godown was started from 1990 and due to shortage of employees no books / stock register was maintained for the spare parts. Spare parts are purchased on demand with the approval of authorities and they are used on actual necessity. 3000 Charkas are working in 66 spinning centres. During 2005-06, 100 Tharies were newly introduced and spare parts for these were supplied from the godown. There is considerable improvement in the production from 1990 to 2007. He further informed that he has not claimed TA or DA for the journey conducted to repair the machines in spinning/weaving units. All the records on clothes were handed over but most of them were now not available in the office. He also furnished an unsigned copy of the report submitted by Shri.Samuel Pothinal SCI (Special Grade) stating that Payyannur Khadi Centre has suffered no loss on cloth transactions and no complaint has been received from units on spare parts. Hence it may be presumed that production units have got spare on demand. Shri.K.Suresh Babu Legal Officer informed that stock verification was done on every March 31st as per stock register and audit will be completed only after this verification. Audit has been completed up to 2012-13 and notice has been issued to Shri.Vijayan for the shortage of spares. But he has not maintained records for movement of spare parts and this may be considered as his dereliction in duty. The loom inspector is responsible for quality of yarn and he has to supply spares parts on demand. Shortage of stock is not reported up to 2006.

The total liability of Shri.Vijayan is as follows

1. Shortage in spare parts	Rs. 1,74,850
2. Shortage in clothes	Rs. 1,51,378

Sri.Samuel Pothinal SCI (special grade) has reported that Payyannur Khadi Centre has suffered no loss on cloth dealing. It was discussed with Secretary Kerala Khadi and Village Industries Board, whether the above statement is correct and if so Rs.151378/- may be excluded from the liability of Shri.Vijayan and his liability may be fixed to Rs.1,74,850/-. But Secretary, Kerala Khadi and Village Industries Board sticks on their earlier stand.

4. Government have examined the matter in detail. The petitioner has not maintained proper records and hence he is no eligible for any remission to the liability already fixed by the Kerala Khadi and Village Industries Board. His revision petition is rejected and sanction is accorded to the Kerala Khadi and Village Industries Board to fix the liability of Shri.K.Vijayan, Loom Inspector Kerala Khadi and Village Industries Board Payyannur Khadi Centre as Rs.2,46,228/- (shortage in spare parts Rs. 174850 + shortage in cloth Rs.1,51,378) and the judgment dated 18/12/14 in WP(C)No.34341/14 is complied here with.
