ORDER

As per Government Order read as 1st paper above, Government have appointed Shri.K.P.Unnikrishnan Nair, Under Secretary (Rtd) and Smt.Jayalekshmi, Confidential Assistant(Rtd) as consultants to the Kerala State Commission for Protection of Child Rights on a consolidated remuneration of Rs. 23,000/- and Rs. 15,000/- respectively subject to the condition that the amount will not exceed the amount arrived at by reducing their pension from the last pay drawn by them. The term of appointment of Shri.K.P.Unnikrishnan Nair and Smt.Jayalekshmi.K.I was extended for a further period of one year from 05.12.2013 as per Government Order read as 2nd paper above. The Secretary, Kerala State Commission for Protection of Child Rights in his letter read above has requested to extend the term of appointment of consultants for a further period of one year with effect from 05.12.2014.

Government have examined the matter and are pleased to extend the term of appointment of Shri.K.P.Unnikrishnan Nair and Smt.Jayalekshmi K.I as consultants from 05.12.2014 to 31.03.2015 under the existing terms and conditions.
