## **ORDER**

As per the Government Order read above, administrative sanction was accorded for an amount of Rs.125,00,000/- for meeting the recurring/administrative expenses of Resource Enhancement Academy for Career Heights (REACH) Finishing School for the financial year 2014-15. Now, the Managing Director, Kerala State Women's Development Corporation, as per his letter read above, has requested for the release of the allocated fund of Rs.125 lakhs for meeting the recurring/administrative expenses of REACH Finishing School.

- (2) Government have examined the matter in detail and are pleased to accord sanction for the release of an amount of Rs.125,00,000/- (Rupees One hundred and twenty five lakh only) to Kerala State Women's Development Corporation under the head of account 2235-02-103-89 (P) for meeting the recurring/administration expenses of REACH Finishing School for women subject to the following terms and conditions.
  - 1. The amount shall not be parked in Banks/Financial Institutions other than Treasuries. The Instructions stipulated in Circular No.75/2009/Fin dated 29/08/2009, shall be followed.
  - 2. The Instructions in Circular No. 84/08/Fin dated 09/12/2008 shall be scrupulously followed.
  - The amount should be utilised during the current financial year itself and for the purpose for which
    the same has been sanctioned. Unspent balance should be resumed to Government account without
    fail.
  - 4. The Managing Director, Kerala State Women's Development Corporation shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate in form No. 44 KFC while forwarding the proposal for further releases.
  - 5. The amount shall be transfer credited to the non interest bearing TSB account and shall be released as per actual requirements only.
